Site Restrictions

Recreational:

The recreational take of finfish by hook and line or by spearfishing, and lobster and sea urchin is allowed. Take of all living marine resources from inside tidepools is prohibited. (Tidepools are defined as the area encompassing the rocky pools that are filled with seawater due to retracting tides between the mean higher high tide line and the mean lower low tide line.)

Commercial:

The commercial take of coastal pelagic species (Pacific sardine, Pacific mackerel, northern anchovy, market squid, jack mackerel) by round haul net, spiny lobster by trap, and sea urchin is allowed.

Other Regulated Uses:

Allows beach nourishment or other sediment management activities and operation and maintenance of artificial structures pursuant to any required federal, state and local permits or as authorized by the Department.




Boundary Access Streets/Markers:

Northern Boundary




Photo taken from top of hill heading down to Big Corona State Park. Boundary extends to end of jetty and then angles slightly north.
